 - Route 537 will be closed at the culvert by where MaryAnn's used to be, on August 17th for 9-10 days. Detour will be posted. See previous email.
 - Thanks to those who attended CORE 13, thanks especially to Craig for his work setting up. If you need CORE 13 between now and December, speak to Alex about options but Squad will not cover costs.
 - Check expiration dates for all medications in the rigs and note on rig duty checklist. Officers aware Narcan is expired, awaiting new higher dosage. Police carry it, so ask police to administer.
 - 64 has new, battery operated tools. Need to be sure charged as part of rig duty. To familiarize yourself with tools, contact Greg, Nick or Chuck.
 - Rig Duty is 1X/week, minimum of 4X/week. If you don't complete it, you'll be reassigned rig duty the following month. Clean/wash the rigs during rig duty.
